Loss Of Dangote Refinery: Rivers, Communities Strive To Improve Ties With Investors

The world was at Lekki in Lagos State last Monday to witness the inauguration of the 650,000 barrels per day Dangote Refinery, the biggest petroleum refinery in the world.

It is estimated that the plant would boost the economy of Lagos State by generating thousands of jobs, downstream investments and taxes n Lagos. It would also attract multi-billion dollar foreign direct investments to Lagos and further enhance the economy in that corridor of the Gulf of Guinea.

The refinery, according to the Chairman of the Independent Petroleum Marketers Association of Nigeria (IPMAN) in Rivers State, Dr. Joseph Obele, will stabilise petroleum distribution with its multiplier

benefits on businesses that depend on the products. "The era of consistent scarcity. The product will be available. There will be surplus of products in Nigeria and that issue of once in a while scarcity will be a thing of the past," Obele told National Point.


While Lagos is celebrating the birthing of Dangote Refinery, stakeholders in the Niger Delta, which produces the crude oil in Nigeria are lamenting the loss of the multi-billion dollar investment to a non-oil producing corridor. This feeling is expressed against the backdrop that most of the crude oil that will be needed by Dangote Refinery will be pumped directly from the Niger Delta through a dedicated pipeline.

Be Sincere At The Ongoing Presidential Election Petition Tribunal: SMBLF

The story of the location of Dangote Refinery began from the Niger Delta, where the founder of the company, Aliko Dangote, had proposed to build the modern plant after his purchase of the Federal Government-owned Port Harcourt Refining Company Limited (PHRCC) was revoked in 2007 by the government of President Umaru Musa Yar'Adua.

Dangote had in an interview admitted that the journey of the refinery located in Lekki started from Port Harcourt after his successful bid to take over the Port Harcourt refinery located in Eleme was revoked by the Federal Government in 2007.

"In business, you need to know before you jump into something. You have to do quite a lot of homework. For instance, Nigeria's refineries were privatized in 2007. We bought

refineries), but after a few months, we had a new government that decided to void the transaction," Dangote told the Nigerian Vanguard in an

'So, since 2007, we've been working on building our refinery. but we didn't finally start something until 2015. Here the capital investments are huge-much larger. And if you are not a big player, you have no way of survival," he said.

Dangote's company, Bluestar Oil Services Limited, a consortium that included Femi Otedola's Zenon Petroleum, Transcorp Group and Sinopec of China, that bought PHRC plant at Alesa, Eleme for \$561 million in the privatisation programme of the Federal Government the dying days of President Olusegun Obasanjo. Other bidders that lost out included Indorama

International Finance Limited, Global Oil and Energy, Mittal Investments Limited, Link Global International Limited and Taleveras Group Oil Works Limited.

In a hurried transaction, the Obasanjo administration signed the papers and handed over the refinery to Bluestar on May 28, 2007, just a day before leaving office. The transaction and its details raised suspicions and became a top issue soon after Yar'Adua assumed office as President.

The sale of the refinery to Dangote was seriously opposed by the two major oil unions, the National Union of Petroleum and natural Gas Workers (NUPENG) and the Petroleum and Natural Gas Senior Staff Association of Nigeria (PENGASSAN), which argued that not only was it an unfair disposal of a national asset, that the welfare of thousands of Cont'd on page 31

"SMBLF restates its timetested position that the future of Nigeria can only be sustained on the basis of true federalism and respect for the autonomy of the federating units.

"SMBLF expresses shock at the escalation of killings, pogroms, total destruction of entire communities and means of livelihood in several targeted areas in select states since after the 2023 general elections, mainly in Plateau, Benue, Nasarawa, Taraba, Southern Kaduna, Kebbi and various states of the South East, where hundreds of armless citizens are being slaughtered daily.

"We note with grave concern that the nation's security agencies have continued to show unwillingness to decisively deal with the perpetrators of these monstrous acts, or rather, deliberately turned a blind eye to the atrocious occurrences, thereby exposing the country to a seeming state of war. It is shameful that non-state actors are allowed to openly tote dangerous weapons about and rampage the country unhindered.

"SMBLF condemns, in unmistakable terms, the cavalier and totally nonchalant attitudes of the outgoing governors of some states over the collapse of security in certain parts of their states, which has continued to exacerbate the worrisome situation and hopes their successors will show greater

commitment to the welfare of their citizens who are the victims of this sad situation.

"SMBLF further warns that the continuous abdication of government's primary and abiding constitutional responsibility of safeguarding the lives and properties of its citizens is an irresistible signal to Nigerians to exercise their inalienable rights of self-defense, by all means.

"SMBLF again deplores the inhuman plight of thousands of indigenous people in the Middle Belt states driven out of their homes and have now become internally displaced persons (IDPs) for years as well as several other internally displaced persons in different parts of the country, left to live in conditions that impinge on their human rights as citizens of this country.

"SMBLF hence, calls on the Federal Government to, without any further delay, facilitate the return and reintegration of these Nigerians to their Communities.

"SMBLF commends the various parties for subjecting themselves to the expected judicial processes in line with the Constitution and the Electoral Laws of the country.

"SMBLF notes with serious concern, the continued snowballing level of indebtedness being incured by the Federal Government. particularly the recent request for \$800 million World Bank loan, and calls on the Federal Government to rescind that

Lawyers representing Oromoni family, Dowen College, Lagos State Government, Nigerian Bar Association, Civil Rights Organizations and other lawyers representing some students accused of torturing Sylvester

Midway to the proceedings which centered around accreditation of lawyers, in our full view, a man rushed in and whispered to the judge. That singular act further created new uncertainties that have generated the apprehensions surrounding today's

Eleme Women Protest Inheritance Denial

omen in Eleme
Local Government Area of
Rivers State have protested the
culture of denying women the
right to inherit family property.

The women raised their voice at a one-day programme on Story Telling on Women Inheritance held at St. Stephen's Anglican Church, Alode, Eleme last Tuesday.

The programme was organized by Mba Okase Initiative Eleme and supported by Kebetkache Women Development and Resource Centre.

Leader of Mba Okase Initiative, Eleme, Dr. Patience Osaroejiji, said, "Eleme culture and traditions have had no place for girls and women with regards to inheritance of land and houses, either from their father's side or their husband's side. This has resulted to so much suffering and has created poverty amongst us as women."

She said this state of affairs has crippled women materially and has made it impossible for women to pursue their economic, social and political aspirations successfully, adding that women who dared to sponsor themselves in political and economic ventures, were stigmatized and branded as irresponsible.

Apart from inheritance rights denial, women are not included in leadership and decision making organs of the communities such as the community development committees, youth leadership and the council of chiefs.

"The only place our daughters are functioning in families is to get married and be the ones to care for those who deny them their rights," she added.

Dr. Osaroejiji said that even these days when communities share land compensation monies, Eleme women are not counted among those to benefit.

"They remember them when mummy or daddy is ill or any problem hits the family. During the sharing of father's property, she is not in the picture. They only give her two yards of George wrapper," she stated.

She however, thanked the Rivers State House of Assembly and the governor of Rivers State, Chief Nyesom Wike, for enacting the Women Inheritance Law, which entitles women to share in their father's properties.

Dr. Osaroejiji urged women to take advantage of the law and seek court protection of their rights in the share of their parents' property.

Land in Eleme culture can only be owned by men, who may lease out to women for farming purposes. Several years ago, when the host communities of Indorama Eleme Petrochemicals Limited started receiving dividends on their equity shares in the company, communities like Akpakpan, Njuru and Okerewa paid male children higher dividends than the female children. Daughters of the communities that had married out were not considered to

benefit from the dividends because the communities said they now belong to their husbands' communities.

A community like Okerewa did not pay the dividends to their daughters married outside or to their daughters who had returned home after they were divorced from their husbands. It was not until 2022 that a new leadership in the community reviewed that. But they only paid a fixed amount of money to their daughters that were married out and the ones that had returned home after they secured divorce from their husbands.

However after sustained protests from women and civil society groups, the discrimination against women in the payment of dividends and land compensations have been between male and female members of the communities have been dropped. But many families still discriminate against women in the sharing of proceeds from the sale of land. The argument is that land is always held in trust by the male descendants as the females would marry and move out.

However despite being

denied material benefits and inheritance rights in their fathers' families, women are burdened with heavy responsibilities in their fathers' homes.

The first daughters play major roles in the burial of their fathers, which require spending a lot of money to entertain guests and feed the community and religious organisations that their fathers belonged to. They are also the first people to contact, when family members need personal care, and when their fathers' families are embroiled in conflicts.

This point was buttressed by Chief Mrs. Mercy Edee, a midwife from Okerewa Community, who revealed that women who were married out of their communities were denied the dividends paid to the community from the Indorama Eleme Petrochemicals equity shares.

"We went and bought big drinks and wine and gave to the chiefs. They drank and went away. They said we should go, that we belong to our husbands, but, as the Lord would have it, those who are on the seat now later called us and compensated us with N50,000 each. Those whose marriages did not favour and came back home, they gave themN100,000 each," she said.

"Pray that government should look into this matter because it is paining us badly," Chief Edee added.

Also speaking, the female traditional ruler of Alode, Madam Mercy Nnenna Onungwe, appealed to the state and local governments to come to the aid of Eleme women by ensuring that they got their rights of inheritance whether in the father's homes or their husbands' home

In a message he sent to the programme, the chairman of Eleme Local Government, Chief Obarilomate Ollor, said the local government was following after the footsteps of the Rivers State governor and was already including women in strategic appointments in his government.

The chairman, who was

represented by Hon. Lawrence Osarobe, said women had the right to share in the properties left behind by their fathers.

The monitoring and evaluation officer of Kebetkache, Mr. Jacob Iniodu, urged the women to get conversant with the Violence Against Women law and the Prohibition of Curtailment of Women's Rights Act and assert their rights under the laws.

Highlight of the programme were two drama presentations that depicted how the Eleme woman is denied her rights in the family, property inheritance despite her contributions to the stability and progress of the family.

Odili Gave Me Secret Of Success - Wike

overnor Nyesom Wike of Rivers State has said the secret of the success of his administration was contained in a list handed him by former governor of the state, Dr. Peter Odili.

The governor, who spoke at a public lecture cum book presentation in his honour in Port Harcourt on Thursday, however did not reveal items on the list that Odili gave him.

He said those who expect that his successor, Mr. Joseph Fubara, will act like him would be disappointed, stating however that the incoming governor would surpass his own performance in office.

Wike confessed that his administration enjoyed tremendous support from leaders and people of the state and would want same support to be given to Fubara because if the incoming governor fails, all the people that worked for his emergence as governor would have failed.

"He is somebody you can rely on. His yes is yes, that I can tell you. He is an accountant, they are very conservative. They don't spend money anyhow. They spend the money where they know it will be useful. So, don't rate us as the same. But he is a very good person," Wike said.

The governor said no two persons are the same and therefore, people should not expect the same kind of relationship they had with his administration with the incoming government.

He assured that Fubara will be committed to deliver on what will make Rivers people happy.

"When people were struggling to be governors, he never one day came to me to say 'Sir, I am interested'. Only those who don't have the interest of the state were those masquerading themselves, running around, those who I know that would sell the State the next day and I thank God they have all left.

"If Rivers people were not in support of our administration, we would not have been encouraged to do what we have done. And so, I say to all of you our leaders, Rivers people that I appreciate every support you have given to us since 2015."

Governor Wike also expressed appreciation to Dr Peter Odili, former governor of the state for writing down the list of things he should avoid if he wanted to succeed. According to him, that list helped him greatly.

In the inauguration lecture entitled, "Democracy, Transformational Leadership and Sustainable Development: The Rivers Experience," Prof. Julius Ihonvbere acknowledged the tactically strategic politics of governor Wike that produced result in the state and beyond.

"Wike brought in a new phase of domestic and international appreciation of the location of the state in economic calculations.

"In terms of infrastructure, there is no one in the history of the state that you can compare comfortably with Wike. Like a man in a hurry to finish an assignment, he unleashed massive interventions, often at great cost, on practically every

Prof. Ihonvbere said Nigeria's democratic practice is characterised by reactionary, opportunistic and antidemocratic actions that have tendency of bankrupting those who are not strong and focused.

According to him, the problem is in the fact that Nigerians are unwilling to think differently, work differently and interact differently.

He said what Nigeria has is not liberal democracy but illiberal democracy because it encouraged closed democratic spaces, extra-legal deployment of power and authoritarian tendencies.

hief Frederick Sunday Alasia, the super powerful, brilliant Chief of Staff to former governor of Rivers State Dr. Peter Odili, who died on Thursday, October 21, 2022, has been buried in his home town, Okparaki community in Ahoada West Local Government Area, Rivers State.

Alasia who died at 74 years, was buried March 25, 2023. National Point sources reveal that Alasia had died unnoticed and his remains undetected for days during the flood that ravaged the Orashi region in 2022. He was said to have been earlier moved to the first floor of his home, from the ground floor as the flood waters welled. Largely living alone, Alasia eventually died unnoticed as family and community members battled to save themselves and property from the flood waters of 2022, generally considered the worst flood incident since the 2012 flood. Found in circumstances perceived to be humiliating, his remains were then taken to a morgue in neighbouring Bayelsa State.

Afflicted with spinal paralysis for decades, Alasia was largely wheelchair bound, even in the hey days of his reign as one of the powerful, colourful personalities thrown up by the Odili reign as governor in 1999, when civilian rule returned in Nigeria.

The brilliant, eloquent Alasia had a personality which loomed large in the state during his controversial time as Chief of Staff to Peter Odili. He had returned to live in his community reportedly in 2018, after selling off his house at Nzimiro, Amadi Flats, Old GRA, Port Harcourt, his cars and other valuable properties.

Alasia was unarguably, one of the foremost political propagandists in the state at a time. He was highly controversial, a brain box and engine room for the good or bad By Sirah Lemmy

Fred attended Baptist High School in Port Harcourt in 1965. At the start of the civil war in 1967, he returned to his family stead in Edagbiri, Joinkrama. During the war, as was customary for young boys at the time, Fred gave himself the nickname Janta Manta, the name of a character from his favourite movie. Janta Manta, was a magician who many agreed was uncannily similar to Fred.

Fred returned to Baptist High School in 1972 for his higher school certificate. He completed his programme in 1973. After school, he was recruited as a teacher in the same school. It was while teaching at school. It was while teaching at Baptist High School that he won a scholarship to further his

Fred attended the University of Wisconsin Superior, United States of America from 1977 to 1981. While there, as always Fred was a star. In addition to being the first black student Union President, he successfully completed three degrees. A double bachelor's degree in Mass Communication and Radio, Television and Film production. And a master's degree in Communication propaganda.

Always a believer in blossoming where you are planted, he returned to Nigeria in 1981 and embarked on his NYSC programme from 1981 to 1982 during which time he was able to put his journalism degree to good use at NTA. While there, he became known for his popular

segment that exposed criminals.

After his NYSC, he became a freelance journalist, his work during his time as a freelancer landed him his job at the Instructional Resource Centre, University of Port Harcourt in late 1983. Fred did not stay as an ordinary staff member for long, he soon became the Head of

Fred's interest in politics had begun to take root. He went on to form several clubs with young men who would later become notable members of society. One of such clubs was the B-Club, formed in the time of General Ibrahim Babangida, 1985-1993. Fred also took on the role of campaign manager for the then National Republican Convention gubernatorial candidate, Chief Zebulum Abule.

During his early days lecturing at Uniport, Fred met a female medical student named Osuo-abo Solomon. A few months after their meeting, the couple got married in August, 1985. During the early years of marriage, Fred focused on his work as a lecturer and the young medical student became a doctor. The marriage was blessed with three children, two girls and a

Unfortunately, Dr. (Mrs.) Osuo-abo Alasia died in 2018 and after the death of his wife Fred welcomed a fourth child in 2021.

In 1998. Fred left the world of smallscale politics after he took on the role as c a m p a i g n manager for Dr. Peter Odili. His Excellence in the game of politics brought him fame, respect and earned him the nickname 'Prof'.

During Dr. Peter Odili's tenure, Fred served in several capacities including Senior Special Assistant to the Governor 1999 - 2000,

Director of the National Department and a member of the University Senate.

Orientation Agency, NOA 2001 - 2003 and Chief of Staff to the Rivers State Government 2003 -

> During his years in Service, Fred Alasia was known for his sharp mind, his intellect, his wit and the unique ways he solved complex problems. His skills made him an invaluable asset to his party, government and people.

Fred Alasia was an intense, strongly opinionated personality, who did not ever suffer adversaries gladly in any shape or form. He fell apart with relatives, friends, associates and this made him a loner, at his home town Okparaki and similar spaces until his lonely end.

Even in death, due to the unsettled misunderstanding, the former governor Peter Odili, numerous friends and associates shunned his funeral rites. Rather, they all graced the burial ceremony of Chief Omunakwe Nsirim (OCC) Apiti of Rumueme Kingdom on the day Alasia was buried.

ational Spokesman of the Ijaw Youth Council (IYC) Ebilade Ekerefe has advised stakeholders from the Niger Delta region to adopt new strategies to tackle the persistent reluctance of the Federal Government to respond to their agitations.

According to Ekerefe, the region must do away with obsolete strategies and adopt the new era of strategic alliances with other ethnic nationalities and intellectuals in an aggressive engagement with the federal government for accelerated development of the region.

Speaking recently in Yenagoa at a colloquium to mark his 36th birthday and the unveiling of his book, "Chronicle of Ebilade Ekerefe, The Journey So Far," he maintained that the Ijaw nation and other stakeholders from the region cannot continue to apply outdated approaches to agitation and expect to achieve the desired result in an evolving world.

The IYC spokesman who used the opportunity to declare interest in the presidency of the ninth council of the IYC. maintained that the new age requires new strategies.

"We are currently in a jet age and we must prepare an army of young, vibrant and intellectually mobile Ijaw youths to drive home our demands.

"The IYC has come of age to look inward and come up with a renewed strategy to confront the myriad of challenges that affect us as a people, if we must get it right," he stated.

attributed the Ekefere successes recorded by the IYC to thousands of youths, elders, and state governors of the region particularly, the Bayelsa State governor, Douye Diri who, he said had supported and encouraged him to speak out against injustice and the failure of the President Muhammadu Buhari administration to commit to the demands of the Niger Delta people.

He said the administration of President Buhari was unfair to the region in the past eight years.

aspect of the disengaged staff offences should be reported to security operatives.

The acting VC said the affected staff are from the Faculty of Basic Medical Science, Medical Laboratory Sciences, Nursing Department, Engineering Department, Faculty of Law, Faculty of Political Science, and included the former director of the university's farm.

Prof. Adagbonyin said a lecturer who was the head of Nursing Science was recommended for sack after he

was found guilty of extorting the sum N32,000 and N52,000 respectively from students, adding that another lecturer who was indicted for sexual harassment was also dismissed.

"The lecturer had claimed to only make advances, but he went to the said girl's church to plead for forgiveness. The victim has been protected and reassigned to another lecturer.

"Out of the 209 disciplinary cases received, the USDC has concluded 132 while 77 cases were pending," the VC stated. .

Tech Firm Launches App For Offline Transactions In Edo

Addressing journalists on the new app in Benin City, Philips Nguzor, chief executive officer (CEO) of the company said the App has come to address the bottleneck in payment system arising as a result of the Federal Government's drive for an economy, devoid of heavy cash transactions in the country.

Tokens, Nguzor disclosed, provides a platform to complete transactions between traders who use the app without a mobile network, an app to reduce the stress in cashless transactions.

"Tokens, this is why we are here today. We are proud to let Nigeria and the world know that we are bringing out this innovation for the world, Africa and Nigeria, especially. We are in a critical stage of a time we are trying to push the economy to a cashless era. Do we get this done over night? No. We all know the system of cashless policy in Nigeria now and how the Central Bank of Nigeria (CBN) introduced the cashless policy that served as pains and sufferings in the lives of Nigerians.

"We all were affected in one way or the other. You see there is bottleneck in the payment system in the country, because we all of a sudden want to transgress or transit to a cashless economy. And the system channels are not strong enough and lack the capacity to move to the direction or speed they want to move".

He said with the Tokens that the company has invented, being offline cannot frustrate your monetary activity.

"I can also pay without having anything to do with network and internet. That is how it operates. With tokens you can do or complete your transactions offline; go to shopping complex, eateries and in anywhere make my payment promptly without having any problem in my transactions'

According to him, transaction is speedy. "The confirmation of the transactions is instant, and there is no reversal of your money. Whether the person you are transacting to or you has internet on his smart phone or not, it does not matter".

The CEO said market women will find the product beneficial. "It will make life easier for our market women because they can use it without data. I observe many who still go to the bank to queue do that because they need cash for shuttling buses. It is understandable because no commercial driver can wait for a transaction to be confirmed. However, this app has come to solve the challenge because the confirmation is instant."

The software works either with or without a mobile network; users just need to enable their Wi-Fi, he said, noting that the app is a product to bridge identified gap in the new monetary policy.

According to him, every measure is in place to ensure a safe system and verify transaction as they are levels of verification in the background. He noted, however, that the firm would not sleep on its oars towards ensuring safer and secured digital application.

Edo Police Apprehend Cultists Plotting Initiation Of Members

he Edo State Police Command says it has arrested three persons suspected to be members of Manphite secret cult confraternity in Benin City

According a statement issued by the command's public relations officer, SP Chidi Nwabuzor, the suspects apprehended at the weekend, identified as Bright Amadin, 34; Brown Amadin 29 and Stanley Omoregie, 27, were arrested in a place they had converged to, "forcefully initiate innocent citizens in order to mark their anniversary."

The statement added that one pump - action gun, three live cartridges, and some clothes with Manphite insignia were recovered from the suspects.

The statement read in part: "On 11/05/2023 the officer incharge of Command Intelligence Rapid Response Squad received

information that some cultists who are members of Manphite secret cult confraternity had planned to converge in an undisclosed location in Benin City to carry out attack on their perceived rival secret cult members and to forcefully initiate innocent citizens in order to mark their anniversary.

"Immediately, the operatives commenced technical intelligence in order to foil their plans, and on 12/05/ 2023 at about 0230hrs, the operatives arrested three of the cult members at Okabere community, Upper Sakponba Road Benin

The statement added that the arrested suspects have confessed to being members of the dreaded Manphite secret cult.

The command spokesman said concerted effort is ongoing to arrest members at large, adding that "sooner, the suspects would proceed to court."

Observations Made At The

Some challenges related to combating organized crime in the Gulf of Guinea were covered during the conference proceedings-and observations made in the course of time include:

▲ The invisibility of modern day crime (and of criminals) has made traditional methods of crime mitigation (becoming more and more unreliable);

New technologies (such as satellite surveillance mechanisms) are yet to develop and improve the effort of crime investigation to deal with present criminal challenges in Nigeria;

Regional collaborations are yet to crystallize into helpful ways of supporting crime mitigation across borders;

Organized crime is complex. and can be carried out by distant operators that may also be literally invisible;

Exploitation of economic benefits has continued to serve colonial/post-colonial interests, which defy crime prevention values that (and are rather promoting crime perpetration);

There is a relational linkage between the natural resource

Delta Govt. Orders Clampdown On Cultism In Schools

he Delta State Government has ordered massive clampdown on cultism and cult related activities in schools across the state.

The state's commissioner for Information, Mr Charles Aniagwu, who disclosed this at a news conference in Asaba on Thursday, said the clampdown became necessary following rising cases of cult related activities in secondary and primary schools in the state.

He said the state Ministry of Education and relevant supervisory and regulatory authorities have been directed to ensure proper supervision of all schools to nip cultism in the bud.

According to him, a number of persons particularly the civil society, have emphasized the need for parents to up their game and for the society to have a rethink on the management of youths and young ones. He said some adults have failed in their duties.

"Unfortunately there are also a number of elders, parents who obviously have not also lived up to their bidding in respect to monitoring the behaviour and attitude of their children.

"As a government, we have directed that teachers must step up their supervisory roles. Teachers are not only to impact knowledge by way of teaching the pupils or the students whatever is in the curricular.

"They must also encourage these students to participate in

extracurricular activities like games that will promote camaraderie among students and pupils,

"We have directed that the Ministry of Education particularly the departments responsible for the supervision of schools be it private or public to also intensify efforts," the commissioner said.

Aniagwu said schools must deal decisively with devious behavior among students to bring law and order in the schools.

He further remarked that any school where such activities take place risks being closed down by the government.

"If there is any child behaving in a manner that is not

expected of him, particularly, in the primary and secondary schools, we have emphasized that beyond the need to sensitize, drastic actions need to be

The commissioner said the hammer will be heavy on schools that fail to act accordingly..

"If any school is found to have wards in cult and nothing is being done about it, government will come down heavily on such schools".

"If you have children in your school and you are looking at them critically you will understand their

behavior; not knowing that they belong to some groups will amount to negligence.

"If you have children who gang up to beat up a teacher, you must look beyond the immediate cause of that attack to interrogate what must have emboldened them to work as a group to attack

You must also take actions that will make the parents know that they too have not done well".

The commissioner said bringing up children right is a collective responsibility and cultism needs to be addressed with urgency.

"It's quite disheartening and it is the responsibility of everybody to take this as a matter of urgent state and national importance because we do know that cultism is pervasive across the length and breadth of this

"Any school where such thing is found to be in existence, the authorities in that school will have to answer and it could lead to closing down of such schools.

"If any school discovers that children under their tutelage are behaving in a manner not expected of children of that age, it behooves on them to know that the responsibility of bringing up those children goes beyond teaching in the classroom to also monitor their behaviour

including how they dress," he added.

Insisting that anti-social behavior is best nipped in the bud, Aniagwu called for tough disciplinary measures against offenders.

'Children of certain age are not free to engage in certain actions otherwise those actions would be termed anti-social. If you have children who gang up at the age of 12, 13, to attack a teacher, you know that there must be something behind it.

"Where ordinarily will they summon such guts or courage? So, if a child does that, the school must first take concrete action including expelling that child and taking up the parents.

"These children would take over from us tomorrow as leaders so we must not fail in our duty to bring up children of sane minds".

He traced present societal ills to parental failure.

"What we are suffering today largely stems from failures of the parents of the past and so parents of today cannot afford to fail more because it will lead to the doom of tomorrow," the commissioner said.

Uncertainly Grips Rivers Civil Servants Over Delayed Promotions And Payments

administration will clear all the challenges facing the civil servants in terms of pension and gratuities, while seeking workers' patience and understanding.

One salient question on the lips of many civil servants and other Rivers men and women is that, bearing in mind these statements, why did the Wike administration leave both the civil servants and the secretariat which ordinarily should be the engine room of government, to rot away.

Our reporter, who went to the State Secretariat in the course of his investigation to get a clear sense of the concerns of the workers, returned with a chilling feedback. "The State Secretariat is like a ghost town. The morale of civil servants is very low. I had to use the torch of my phone to climb and descend the staircases. You have to be very careful so that, you don't bump into other people. Not so fortunate people that are compelled to use these

was no sign of electricity within the Secretariat premises".

More worrisome is the issue of lack of water in the Rivers State Secretariat. The stench of unflushed human waste, hangs heavily on all the floors of the blocks in the Secretariat.

Hausa cart pushers are hired to get water for civil servants in jerry cans. Fourteen jerry cans cost about N1,000. The men from the North are doing brisk business, with a little nudge from the people at the helm of affairs in Rivers State.



Transnational organized crime is a problem that affects all of us among the populations in the (Gulf) region;

There is a co-relationship between created conflicts in conflict-afflicted areas and the formations/sustenance of organized crime in the (Gulf);

There is usually a collaboration between international crime syndicates and Nigerian state/corporate officials who wield high-level influence in the industries related to the problem of organized crime;

State effort in setting up mere task force outfits cannot automatically translate into desirable result, but may even help benefit the few corrupt/thieving members of society;

Environmental pollution taking place around the Gulf of Guinea is contributing to minimize ecological (or natural resources)services that traditionally benefit the

people of the region; International interests approximating to superpower struggle from part of insecurity difficulties and related challenges across Africa's coastal regions (including Gulf of Guinea);

We Will Stop The High Cost Of Food In Bayelsa - John

That does Bayelsa S t a t e commodities and export development agency

Our responsibility is to promote export business in Bayelsa State, export products for sale, export products overseas, encourage internal food production and encourage international export production so that we can produce a lot and send them overseas.

What are some of these export products?

We have identified seventeen export produce that we can use to make a lot of returns to the state government and some of these export produce we have them in They are palm oil, plantain, we have cassava and cassava produce which is being processed into Garri and other things. We also identified crops like bush mango which is Ogbono and we also have Crayfish, Shrimps and Snail. We have Water Yam. We have Water Snail, Bamboo Raffia Palm, Potatoes, Banana and others.

How do you intend to preserve them so that they can get out of the state without going bad?

We have a warehouse where we will preserve those export crops but we don't keep them in our warehouse beyond 48 hours. Some are perishable goods so those ones that are perishable, we sell them off. We sell them back to the public from our plaza at government controlled price.

Can people get anything from there now?

For now, the ones we had, have been cleared, we are waiting for new things to come.

How do you assemble all those produce, because I know almost every part of Bayelsa is riverine?

We assemble them through our local government field officers. We have field officers in all the eight local government areas. These field officers interact with local farmers and there are people we call vendors. These vendors relate with our field officers on a daily basis. So if they have anything, they bring it to them and we pay at a subsidized rate.

There is this saying that Bayelsa State is easily prone to inflation. Don't you think what you are doing can increase inflation and cause food shortage because you get all these things and dump in a particular warehouse and they are sold out in bulk?

No. It will even reduce the cost of food items in the state. Now we have them in bulk and at a cheaper price for the people to buy. We collect from farmers and we disburse to the general public and at the same time we disburse to exporters who want them in tonnage and those we cannot sell out in tonnage we sell at a retail price. So the essence of this programme is to reduce cost of food items in the state. We are indirectly


controlling prices of commodities in the market. Most people will prefer to come to the plaza to buy rather than going to Swali market by so doing, we are forcing the general market to reduce their prize because when you have your goods and people are not buying and everybody is going to one particular pool to collect, that will generate this awareness and then people will begin to say instead of us to leave our food items unsold, they will sell it at the particular price that is affordable to the people. Indirectly, we are using that system to push down prices of goods and services in the society.

What is the agency's relationship with the state and federal governments?

We are working in collaboration with the Nigerian Export Promotion Council and at the same time we are working in collaboration with Nigeria Export and Import Bank where we are expecting some of our export grants to be given to the state. The federal government budgeted about 30 billion naira for exporters this year. Now the highest state with the export growth will be able to access this money through the Central Bank of Nigeria and then the money will be brought to the state for exporters to benefit and it will energize the exporters.

How can people be registered?

We have registered about thirty eight exporters of Bayelsa origin who are farmers who are now waiting for federal

government wants to give six million naira which is our take off grant. We are still expecting that. As soon as the state government makes that available to us, Bayelsa will never experience increase in the prices of food items anymore.

What plans have you put in place to make sure that you preserve these items?

government. The state help the people. Because most of the farm produce that we will have in the warehouse would have served as a succor to a lot of people who had nothing to eat during the crisis. We would have been giving out garri, plantain, and so many food items from there. So it's a way of preserving for the rainy days because no one knows when we can run into crisis. Now we are

encouraging our farmers. We have enough land for farm but our people have decided to run away from the land for oil money, government appointment and all the rest. That is why most of those things are not coming up but, if we can move them back to farm through this process, as long as the farmers are given incentives and they are receiving money from us, they can go back to farm immediately. So that will energize them to go into farming even the youth can go into farming with the hope that people can come and collect and pay. Before you know it, we will have enough food inside and outside the ware house. All these things will work if the state government finances us. And at the same time, we have product monitoring unit which monitors every food product that moves out of Bayelsa state. Once it is at the trucking level you are going to pay N2000 at the tollgate to the agency and if you are not registered, you are not entitled to move the products out of the

Won't all these cause food shortage in the state?

It will not. As we are right now, the consumption level of farm produce in Bayelsa is about 2.5%. That is to tell you that we are not buying. They are just moving them out. There are people who go straight to the farmers, pick and take them out and then bring them back to the state at an exorbitant price. That is why you are having this inflation. So if we are able to stop them, they can't come in and pick. We control all the process and then we supply back to the state at a government own price. People now buy at a lower price rather than inflation price.

When do you intend to surmount all the challenges that are now staring you in the

Two years from now, Bayelsa will know their food ratio. Bayelsans will no longer be seen as a state that is having high cost of living. Export produce will increase and the state government will make so much money to plough back into the farming sector. Once this happens, people will be coming from outside to buy. And we will have a market space for export produce.

How do you come about the 2.5% Ratio?

2.5% is the consumption ration. We have calculated the ration. We are looking at the import and export ratio in the state. The state consumes more of food from outside than food produced from within. You now discover that the circulation of what we have in the market comes from outside and that increases the price of goods and food in the state and it is hiked from transportation, road levies and those charges are being put on the items.

Prior to the post-election cult related killings, between November and December 2022, similar incidents claimed the lives of nine people when two suspected rival cult groups clashed near an internally displaced persons (IDP) camp located inside the newly commissioned Ahoada campus of the Rivers State University "fatalities, kidnappings, and (RSU) in Ahoada Town.

At the time of submitting its report the commission noted that 94 persons were killed "between November 15, 2014, and April 11, 2015." Most of the movements which occurred from the Opobo/Nkoro axis and largely around the Ijaw ethnic nationalities were also instigated by mostly ethnic considerations due to the emergence of an Opobo-Ijaw son as the governorship candidate of the PDP. This is understandably so because of the 24-year wait by the Ijaws to occupy the brick house which used to be their traditional home. The Ijaws in the last 24 years have suffered political irrelevance, loss of social and cultural landmarks, underdevelopment and policy of structural exclusion. Within

The movements and crossalignments to a large extent did not only weaken the claim of the APC to the Brick House, it further added to the toxicity of the electoral process in the state. Part of the toxicity also led to the emergence of draconian laws which led to unprecedented violence in many parts of the state. For instance in the weeks leading to the elections, the state grabbed negative headlines with targeted attacks against political parties by cultists who also act as political thugs. In many instances they violently disrupted opposition party campaigns and orchestrated clear threats to life.

The disruptions were anchored on the strength of 'Executive Orders' promulgated by the Rivers State government few months to the elections. The executive orders mandated political parties in the state to seek approval from the state government before they can hold political rallies in the state. The executive orders which are known as 'Orders 21 and 22,' also mandated political parties to relocate their campaign offices from residential areas.

A report published by the Fund for Peace and The Foundation for Partnerships Initiatives in the Niger Delta (PIND) in May 2016, on election related cultism induced violence, reported that "during the three months (Dec-Feb) prior to the March 16 legislative elections, cult related violence resulted in over 100 fatalities across the state. The 2023 electoral process of political realignments in Rivers State. The state has been in the grip of the People's Progressives Congress (APC) briefly captured the state in 2014 when the then governor, Rt. Hon. Rotimi Chubuike Amaechi decamped left the PDP, the PDP reclaimed the state after the current governor won his first term in office. The position of the PDP was consolidated with another victory in 2019 and has remained so until the just concluded 2023 elections.

But in spite of the PDP holding power in the state, a lot has however changed since the conclusion of the 2023 election. The change which was induced by the fall-out from the PDP presidential primaries, is gradually redefining politics of the state. The change also threatens the

candidate.

Like the PDP, key political actors within the APC in the state also worked against the APC presidential candidate Asiwaju Bola Tinubu. Although the challenge of the APC has its root in the protracted conflict amongst party bigwigs in the state, it however escalated with the outcome of the party's presidential primaries where the leader of the party in the state. Rotimi Amaechi emerged the first runner-up. Again, just like the PDP, while some party members refused to campaign for the presidential candidate Bola Tinubu others however aligned themselves with the party's presidential candidate and that of the Labour Party.

At the national level, the APC National Legal Adviser Mr Henry Bello also withdrew from the party's petition against the PDP at the governorship election tribunal last week. There are talks that the withdrawal of the national legal adviser from the petition is part of a deal between the APC and governor Wike, as the governor's reward, for his technical assistance to the APC presidential candidate. But former National Publicity Secretary of the defunct new Peoples Democratic Party

relieving Mr Bello of his role over his action, also called for further sanctions against him.

The APC in the state had repeatedly accused Mr. Tinubu and some APC stalwarts of undermining the Rivers State chapter of the APC as a result of their romance with the Rivers State governor. The APC presidential candidate who is now the president-elect and his lieutenants, made several visits to the state during and after the elections, without recourse to the state chapter of the APC. Political watchers interpreted the visits and the general attitude of the national leadership of the APC as a foretaste of the internal battle that may eventually consume the Rivers APC when Mr Tinubu takes the oath of office on May 29, 2023.

The evolution of multiple pre-election ambitions

The period also witnessed the evolution and launch of new ambitious interests, mainly within the state chapter of the APC. Notable political actors like Senator Magnus Abe, Dr. Dawari George and many others left the party to fly the flag of other political parties. Like a massive hurricane, there was also an unprecedented exodus of grassroot party members to the ruling PDP.

Legislative Re-Run Elections' stated that in December 2015, over a dozen communities were reportedly attacked by cultists resulting in over 17 fatalities in Ogba/Egbema/Ndoni, while clashes between rival Icelanders and Degbam cult groups caused three fatalities in Ikwerre. The report further stated that "in January 2016, over 20 people were reportedly killed in series of cult violencerelated incidents in Ahoada East, Ahoada, West, Obio/Akpor and Ikwerre LGAs" and another "three fatalities when security agents raided the home of an exmilitant leader."

In response to the violence the Rivers State government set up a 'Judicial Commission of Inquiry to investigate the killings and other violent acts/matters that occurred during the December 10, 2016 rerun/supplementary elections to elect members of the National Assembly and House of Assembly in Rivers State.'


The Inspector of General of Police also set up a joint investigative panel to investigate the violence that accompanied the elections. However a Federal High Court in Abuja, in a suit filed by the Rivers State government, which challenged the authority of the IGP, declared as illegal, the Special Joint Investigative Panel constituted by the IGP, to uncover those behind the violence.

In 2019, a similar tide was repeated after the state recorded six deaths including a Nigerian army lieutenant.

The Courts as new battleground

The post-election fragility in 2023 has also seen a shift to the courts. The Rivers State governorship and legislative election petition tribunal was relocated from Port Harcourt to Abuja due to concerns growing insecurity. Prior to the shift, there were palpable threats of possible violence as members of the PDP routinely barricaded the entrance to the office of the Independent National Electoral Commission, in Rivers State in protest.

The PDP insisted that they should be granted a joint observer status to enable them simultaneously inspect all election materials used for the conduct of the 2023 elections in the state. The request meant that the PDP will jointly inspect the materials with the APC which had been granted the permission

Away from the tribunal is another brewing legal crisis. A Federal High Court in Port Harcourt, on May 17, 2023, issued a bench warrant against Rt. Hon. Rotimi Amaechi; Mr Tonye Cole, the Rivers State governorship candidate of the All Progressives Congress (APC); and others. The court issued the bench warrant against the entities in a criminal suit filed by the state government. The court said the bench warrant was necessitated by the failure of the defendants to appear before it. The Rivers State government filed the fresh criminal law suit against the defendants, on allegations of funds and corruption in the purchase of government assets between 2007 and 2015 when Mr Amaechi was governor of

The lawsuit came on the heels of the report submitted by the panel of inquiry set up by the Rivers State government in 2022, to probe Mr Amaechi over an alleged withdrawal of N96 billion from the state treasury during his tenure as governor. The panel which also investigated the sale of assets by the former governor indicted Sahara Energy for its role in the purchase of the assets.

state government had in October 2022 withdrawn a similar suit against Mr Amaechi and Tonye Cole. Many political

Uncertain future of key political actors in the state

Beyond the cult wars and legal battles, the fate of most of the key political actors which hangs in the balance, in their various parties are also contributing to the tension in the political landscape. There are hush speculations about a possible implosion that may ravage the state in the days to come, if speculations and permutations are anything to go by. While some sources close to key political actors speculate possible transitions of their principals to new political parties, others say it is too early to draw conclusions.

For instance, some leaders misappropriation of public of the Grassroot Development Initiative (GDI), informed this reporter that the governor does not intend to leave the PDP for anyone. They argued that the governor would rather destroy the party than to just walk away. However, two Councillors disclosed that there are actual talks about the governor decamping to the APC within the governor's inner circle. They said the governor is however waiting for the outcome of the various cases at the governorship and presidential tribunals.

One of the councillors from Ikwerre LGA who preferred not Interestingly, the rivers to be named stated that the governor will most likely leave the PDP for the APC. He said "the signs are eminent and the governor's body language watchers have however clearly shows that he is

preparing the ground for his eventual departure from the party." He also informed that such a move will not be popular with most bigwigs of the party. According to him, the governor did not manage his politics very well with the national leadership of the party. He also argued that even if Mr Tinubu eventually rewards the governor for his support, such reward may not necessarily trickle down to his followers. On what becomes of Wike in view of his wrangling with the national leadership of the party, the source said "if you observe the national leadership is using diplomacy on him; they are waiting for him to finish his tenure before moving against him. They are aware that if they move against him now, he still has many followers because of the money he controls as governor and that may not be too good for the party.

However, another serving councillor in Port Harcourt City Local Government Area informed that there is an uncertainty on the governor's next political move. He said the governor has kept everything to himself and is not giving information to most of his key allies on the expectations from his alliance with the APC. He said: "Since after the election, the governor has not been talking. Even his G-5 friends have been silent. So, nobody knows what's on his mind. He is not saying anything even those who are very close to him are complaining because he's not telling them anything."

When asked if the governor's refusal to disclose his plans has to do with fear of

betrayal, the councillor said: "It is possible. Remember what happened when he instructed us to mobilize for the APC; it was supposed to be coded. But even before we started the mobilization, the news was already everywhere."

He however said everything will become clearer after the swearing in on "May

But, a former State Secretary of the PDP disclosed that talks about the governor's movement to the APC "is neither here nor there." He argued that before the governor can make such a move "the APC must first fix the Amaechi factor within the Rivers APC." He said "Tinubu and the APC faction fighting Amaechi will have to ensure that Amaechi is eased out in order to allow Wike to take over the party structure." According to him, until that is done, such a plan will be herculean because of the "unwelcoming attitude of some Tinubu's aides who are not comfortable with Mr Project's' towering influence." however stated that "everything is on the table especially if Tinubu wins at the tribunal.'

All the sources who spoke to this correspondent also informed that the governor however envisages an impending onslaught by the national leadership of the PDP against his strangle hold of the party in the state if Atiku wins at the presidential tribunal.

The former Minister of Transportation was less visible during the presidential campaigns. Many had thought

that Mr Amaechi who was the first runner-up at the APC presidential party primaries, would be given a prominent role by the All Progressives Congress Presidential Campaign Council (APC-PCC). Mr Amaechi, a two-time Director-General of the APC Presidential Campaign Organisation (APC-PCO) between 2015 and 2019, was however named Special Adviser on Infrastructure of the PCC for the 2023 presidential election. His diminished visibility and lack of strong reference by the party's presidential candidate even on his several visits to Rivers State, led to multiple interpretations that the two may be at cross-purposes.

The interpretations gained further prominence, when the National Protocol Director of the APC-PCC, Chief Tony Okocha, publicly claimed that the former Minister of Transportation was no longer the leader of the APC in the state. Tony Okocha who was a former Chief of Staff to Amaechi, accused the former governor of anti-party activities. Okocha had claimed that on the eve of the presidential election, Mr Amaechi ordered his supporters to vote for the presidential candidate of the PDP. He said, "A day to the presidential election, he ordered his supporters to go and vote for the presidential candidate of the PDP. And himself, we have it on record that he voted for the candidate of the PDP, Atiku." Although Okocha's position was dismissed by the leadership of the party in the state, the silence of the national leadership of the APC on the cold war, has further given credence to Mr Amaechi's uncertain future in the party in post-Buhari regime.

In a chat with the State Publicity Secretary of the APC, Mr Darlingron Nwauju, on the future of Mr Amaechi in the party, Nwauju said Amaechi as one of the founders of the party cannot be pushed out of the party by anybody. He stated that Mr Amaechi has also not told anybody that he's leaving the APC and that "his body language does not suggest so." On the battle for the soul of the APC in the state and the possible take-over of the party by the governor Nyesom Wike, who is in strong political romance with the Presidentelect, Nwauju said, "I know that Nigerians are already aware of what is going on in

Rivers State. The fact that somebody once described the APC as a cancer...and today you're romancing with the cancer; we have no problem with that.

"The only problem the person has after condemning the APC is a crisis of integrity. What will be the public perception of that person? It shows you that the person is inconsistent. So, it is his problem; it is an image crisis for him, not for us."

Commenting on the possible return of Mr Amaechi to the PDP if Mr Wike does otherwise to the APC, Mr Nwauju said, "Recall that Amaechi was pushed out of the PDP in 2014 after the party structure was taken from him. So, he cannot now wake up to go back to the PDP."

On the seeming or looming loss of the state party structure as was the case in 2015 and the implications on the political future of Mr Amaechi, the publicity secretary said, "The truth is that if I now answer you by saying it is the same thing that is playing out, then you will expect that the next answer should be that, we will move if he is expelled or he is suspended. I'm not a Nostradamus for me to predict that my principal will be expelled or suspended from the APC. So, since I'm not a Nostradamus, I cannot predict or I cannot tell you that we're going to leave the APC. For now, I'm sure that we are members of the APC.

"When the APC came to the Niger Delta, everybody said it was an Islamization agenda and he said no, that he has interacted with the then General Buhari, and the man never discussed with him about an islamization of Nigeria. And so a lot of our people who

embrace the APC were killed because of Amaechi. You will recall our campaigns at Okrika, we were shot at some persons including a policeman died. So, on the day that Buhari and including the President-elect in September of 2014 came to Rivers State, he was stoned at the Port Harcourt Airport by the same persons who are now trying to hobnob and romance with the APC. So, you see how people can be inconsistent. "So what I'm trying to say is that Amaechi has laboured to bring the APC into Rivers State and into the South-South, and so, if he will be rewarded with whatever, we leave that to God. But, as at today, I can tell for sure that we have not contemplated, he has not told us that we're going to leave our party; it is our party."

Describing Wike as a possible tenant, he said, "The landlord does not need to argue over the ownership of his property. It is the tenant who is trying to lay claim to that property that should now show us his C-of-O. There are people who laboured for the APC, to build the structures in Rivers State and in the South-South. Those are the landlords I'm referring to and if you're going to pay them back in wickedness for their loyalty even when the APC was an unpopular brand and unacceptable, even against our own brother from the south-south who was a sitting president; there's no argument."

On the reasons for the seeming cold war between Mr Amaechi and the President-elect, Mr Nwauju stated that Mr. Tinubu's alleged discriminatory behaviour against Amaechi is hinged on the decision of the former Transport Minister to contest for the party's presidential

ticket. "For me, the only possible reason I can point to is the fact because my principal aspired to be the flag bearer of the APC, because before that time there was no publicly known issues between Sen. Tinubu and Amaechi."

Sen. Magnus Abe

Senator Magnus Abe left the APC to fly the flag of the Social Democratic Party (SDP) at the just concluded governorship election. His departure to the SDP was preceded by a bitter rivalry between him and the former Minister of transport Rotimi Amaechi. His fight against Amaechi is predicated on a number of multiple issue ranging from imposition of candidates and the general lack of internal party democracy within the APC in Rivers State. In 2019, their fight led to the disqualification of all APC candidates in the state by the

However, although he eventually decamped from the APC, he still campaigned and worked for the presidential candidate of the APC whom he often describes as a worthy political ally. The former lawmaker, who also recently withdrew his petition against the victory of the PDP at the governorship election tribunal, has been serially described by some APC elements as a PDP mole. His decision to work for the presidential candidate of the APC and the withdrawal of his petition from the tribunal has however sparked conversations about a possible return to the APC after May 29. Part of the conversations has also revolved round an alleged deal between him, Wike and the President-elect. The deal according to political watchers, may have been brokered by Mr. Tinubu as part of compensation for Mr Wike's support for the

presidential candidate.

A return to the APC may however have a profound effect on the soul of the APC in the state, as it could revive the intractable conflict between him and Mr Amaechi who himself is also facing an uncertain political future.

Commenting on the developments, a former legislative aide to Senator Magnus Abe, Mr Friday Kennedy, stated that the political future of Sen.

A be will be determined by the interest of his followers and that of Rivers people at large. He said Abe's decision to work for Mr Bola Ahmed Tinubu was informed by an age-long relationship they both shared. While dismissing the allegation of being a mole, Mr Kennedy stated that the "relationship between both men precedes politics."

On Abe's decision to withdraw his petition from the tribunal, he stated that the decision to withdraw the petition from the governorship election tribunal, was based on a pragmatic assessment of certain indicators which are informed by the need to move the state forward. He said the withdrawal was a collective decision taken by key members of Abe's political family and reflection of the wishes of progressive Rivers people.

The key highlights of the realignments will however be tested after the governor would have left office and when Mr. Tinubu takes the oath of office on May 29, 2023. The fragility would also continue at least for the foreseeable future unless leaders of thought and critical stakeholders take steps to build a citizen led consensus that will determine the political future of the state.


The onus however lies on the incoming governor to lead the process of reconciliation. To do this he needs to first shrug off the burden of expectations tied to his emergence by the outgoing governor, who disenfranchised other aspirants to pave the way for his emergence as the party's candidate and eventually the governor elect. The reconciliation should also involve truth telling and strong apology offered to citizens for the violent disruption of the electoral process in the state.



Dangote Launches Africa's Biggest Oil Refinery - Vigeria's new Dangote petroleum Dangote petroleum operations of the refinery. 4 Ways It Will Affect Nigeria operations of the refinery.

refinery is Africa's biggest-it will produce 650,000 barrels a day, giving it the potential to address the country's energy supply crisis. First product from the refinery is expected to hit the market by the end of July 2023.

Owned by Nigerian industrialist and Africa's richest man, Aliko Dangote, the refinery is expected to boost domestic refining capacity, getting rid of the current consumption shortfall. It will also reduce import dependency and stimulate economic growth.

It is the first privately owned crude oil refinery in Nigeria. Nigeria's existing refineries, plagued by operational inefficiencies under government control, have failed to meet the growing demand for petroleum products. Substantial imports have become necessary.

Nigeria currently imports more than 80% of its refined petroleum products. The country is the largest importer of refined petroleum products in Africa. Local production will therefore massively cut the country's import bill.

According to the Central Bank of Nigeria, the cost (including freight) of petroleum products imports into Nigeria doubled over a five-year period from 2017 indicating an annual average of US.1 billion to 2022.

The central bank says the average annual cost of petroleum products imports to Nigeria could clime further if the country continues to rely on several fuel petroleum imports.

This money can now potentially be saved with Dangote refinery plugging the supply shortfall.

In my previous research, I have found that there is a link between Nigeria's crude oil export dependency and its weak local refining capacity. This is also the case with Mexico, which exports its crude abroad for processing.

Based on my experience in the sector, I set out the four areas where the Dangote refinery is expected to make an impact on Nigeria's petroleum sector and, by extension, the Nigerian economy.

Reduced oil import dependence

The most notable impact of Dangote refinery will be the increase in local refinery capacity, which will reduce imports.

Dangote refinery is expected to help Nigeria meet 100% of it's refined petroleum product needs (gasoline, 72 million litres per day; diesel, 34 million litres per day; kerosene, 10 million litres per day and aviation jet, 2 million litres per day), with surplus products for the export market.

The refined petroleum output from the refinery in combination with other refineries in Nigeria is expected to meet the shortfall of the estimated daily consumption of 72 million litres

The country has faced

shortages in the past, which have caused prices to surge for transport and basic commodities.

Recent fuel shortages have been blamed on the Russia -Ukraine war. The price of imported fuel rose more than 1 0 0 % . Importers operated at a loss due to price ceilings set by the government.


Besides eliminating

import dependency, the Dangote refinery can potentially reduce Nigeria's crude oil export dependency as more crude oil will be refined domestically.

Refining crude oil locally will enable the country pay for the refined product in naira which will save scarce foreign exchange and generate revenue in exported refined petroleum products.

The Central Bank of Nigeria says Dangote refinery could engender foreign exchange savings of several US billion dollars annually for Nigeria.

The establishment of the refinery is also likely to help reduce the cost of production for industries that rely on petroleum products such as diesel to power their operations. In turn, this should increase their competitiveness in the global market while promoting local industry capabilities.

The refinery could also create an environment for allied industries to emerge in and around it. For instance, businesses in transport, housing and telecommunications will benefit from the construction and

And the refinery should create jobs and entrepreneurship opportunities.

While under construction, the refinery employed about 40,000 workers - 29,000 Nigerians and 11,000 foreigners.

The jobs were in engineering, construction, manufacturing and operations, among other areas.

In full operation, the refinery, according to media reports, is expected to create over 250,000 direct and indirect jobs. I believe this is a fair estimate.

The country's current unemployment rate is expected to reach 40.6% in 2023.

Possible increase in carbon footprint

The operation of Dangote refinery raises concerns about its potential impact on Nigeria's net zero emission goals. Net zero is an ideal state where the amount of greenhouse gas emissions produced and greenhouse gas emissions taken out of the atmosphere is balanced.

Decarbonisation efforts are required for countries to achieve net zero but the path and time might differ as countries may want to take a gas-led approach to transition to renewable energy.

At the COP26 climate change meeting in 2021, President Muhammadu Buhari committed to net-zero emissions by 2060. This is to protect Nigeria's environment and ecosystem from the impact of climate change and reduce the country's greenhouse gas

Nigeria has an Energy Transition Plan to get closer to a more sustainable economy. The plan assumes greater use of natural gas as a "transition fuel".

Oil refineries contribute about 4% of the global carbon

emissions.

The Dangote refinery complies with World Bank, US, European and Nigerian norms for emissions and effluents.

Conclusion

The Dangote refinery is a significant step towards self-sufficiency in Nigeria's energy

However, the refinery is still reliant on fossil fuels, and it is not a long term solution to Nigeria's energy needs.

Nigeria has significant renewable energy potential, including solar and wind power.

Renewable energy can be harnessed to meet Nigeria's energy needs in a sustainable manner. Therefore, Dangote refinery should be viewed as a stepping stone towards a transition to cleaner energy sources in the medium term.

It is essential that Nigeria continues to invest in renewable energy and explore ways to reduce its reliance on fossil fuels to achieve its net zero emissions

Stakeholders Call For Collaborative Action Against Drivers Of Organized Crime In Nigeria And The Gulf Of Guinea

Stakeholders have called on the federal government to widen the community of policy makers to include non-state actors in its drive to effectively respond to the drivers of organized crime in Nigeria and the Gulf of Guinea.

The call was made at a Conference on 'Organized Crime in Nigeria and the Gulf of Guinea.' The conference which was organized by the Youth and Environmental Advocacy Centre (YEAC-Nigeria) was held on April 28, 2023 at the Landmark Hotel, Port Harcourt.

In his welcome address, the Executive Director, YEAC-Nigeria, Mr Fyneface Dumnamene Fyneface, commended the guests for their various roles towards a national re-armament and moral re-orientation. He stated that participants and members of the panel of discussants were carefully selected in view of their rich background on issues of conflict, security, and policy and community development.

Explaining the objectives of the conference, Mr Fyneface informed that the conference was intended to amongst other things build a collaborative response to threats posed by domestic and transnational organized crime. He said there was a need to "expand the policy community that does not depend on static actors alone to drive change."

Speaking further, Mr Fyneface observed that many countries facing challenges of insecurity within the Gulf of Guinea are all struggling with challenges of violent conflicts, corruption and poverty on the domestic front. He therefore called on guests to proffer actionable solutions "towards improving the response to threats posed by organized crime in the region."

The keynote speaker, Professor Fidelis Allen, Head, Department of Political Science, and former Coordinator Centre for Conflict and Gender Studies, University of Port Harcourt, stated that the sub-culture of crime is an industry that draws strength from both local and international dynamics. He argued that until a proper diagnosis is made on the actual cost of crime and its reward system, organized crime within the region will continue to be sophisticated.

Tracing the origin of

conflict in the Gulf of Guinea to the movement of international capital, Prof. Fidelis stated that the "goals of international capitals are not to develop or empower but to take as much resources as it can." He said, "The political economy was disruptive and exploitative. The post-colonial political economy was to maintain the relationship between the exploiter and the exploited."

Prof Fidelis further called for the adoption of a collaborative effort which he said should include both structural and relational approaches in responding to the myriad of conflicts in the region.

In their separate presentations, members of the panel of discussants called for the adoption of multi-dimensional approaches to crime in the gulf of guinea. They also called for multilateral

interventions that integrate home grown solutions. Commenting on the need to unbundle the political economy around organized crime in Nigeria and the Gulf of Guinea, Managing Editor of the National Point Newspaper and Gender Expert, Chief Constance Meju who was represented by Mr Sunny Dada, called for the review of national and regional security strategies.

Key highlight of the conference include the official launch of a 'Network on Organized Crime in Nigeria and the Gulf of Guinea' (NOCINAG). The network which is made up of organizational membership, is drawn from civil society and policy communities.

its members in the company would be jeopardized by the transfer of ownership to Dangote and partners.

However, the host communities in Eleme and Okrika Local Government areas were eager to enter into a memorandum of understanding with the new owners of the refinery and begun discussions moderated by the Bureau of Public Utilities with Bluestar when suddenly the Yar'Adua government gave in to pressures from NUPENG and PENGASSAN and revoked the privatization deal and refunded Bluestar the \$561 million dollars already paid to the Federal Government. Today, the federal government has entered into a \$1.5 billion loan arrangement to rehabilitate the refinery after it had remained idle for almost ten years.

After its purchase of the Port Harcourt Refinery was revoked, Dangote began to explore the possibility of erecting a Greenfield refinery within the Eleme/Onne industrial hub.

Prospects of land acquisition had begun and the landowners were eager to talk with the company. Somehow, the talks never took off. Dangote was no longer forthcoming. Feelers said the company was concerned about militant activities that were

rampant then in the Niger Delta and had moved west to Edo State, around the Gelegele Basin. That move also failed and the companied continued its movement westward to the Ondo/Ogun coastal axis before it finally settled in the fast developing Lekki Free Trade Zone in Lagos State, where it has just commissioned the world's largest refinery.

Mr. Olungwe Obele, an indigene of Eleme, said with the benefits that the communities have been receiving from Indorama, which bought over Eleme Petrochemicals Company Limited, the people are now eager to made things easy for prospective investors.

Indorama, which bought over EPCL in 2006, has been posting impressive profits and dividends for the host communities. The communities do not only receive dividends every quarter, the company also sponsors corporate social responsibility projects in the communities.

Rivers State Government, which owns 10 percent of the shares of Indorama is also receiving dividends from the company in billions every year as well as collecting income taxes from the operations of the company.

Very recently, when the company wanted to acquire more land to expand its operations, it was the Rivers State Government under Governor Nyesom Wike that that undertook to acquire the needed lands from the host communities under the Land Use Act to smoothen the process.

Also, when Indorama decided to construct an 11-kilometre road dedicated to transporting its products to the Onne ports for exports, the state government took over the construction of the road to avert a likely intractability in the negotiation between the company and the communities through which the road would pass.

morning on the next adjourned date as Ijaw youths and elders prepared to move to Epe. information filtered in that the Court has moved from Epe to Ikeja GRA for security reasons. Swiftly our people moved to Ikeja to witness what was going on. After few sittings with increased number of people trooping into the Court with the press in attendance, the venue was again changed to Legacy Building Court premises in Ogba, Ikeja, Largos with same judge Mikhail Kadiri presiding. Court 20 on the second floor was allocated to him. With the movement from Epe to Lagos we started to notice some curious reasons for adjournment like:

- After all parties were seated in Court, the Registrar walks in to announce that Court won't sit because his lordship is off to attend a meeting.
- A day to the next sitting, Registrar sends text message to all parties that due to a

Presidential visit to Lagos which could impede vehicular movement around Ikeja axis, Court would not sit. On that particular day, I didn't get the registrar's message on time and breezed into an empty Courtroom. I met an Admin staff and asked: "Where are my people? "No sitting today" he told me. Guess what? There was no road closure.

Tina Turner – Tributes Pour In After 'The Best' Singer Dies In Switzerland Aged 83

Tina Turner, one of the greatest rock 'n' roll singers of all time, has died in Switzerland at the age of 83.

"Tina Turner, the 'Queen of Rock 'n'
Roll' has died peacefully today at the age
of 83 after a long illness in her home in
Kusnacht near Zurich, Switzerland," her
publicist said in a statement, May 24.
"With her, the world loses a music legend
and a role model."

Tina Turner, the singer rose to prominence performing with her husband Ike Turner in the 1960s before overcoming his violent, abusive behaviour to go on to become a charttopping solo artist.

Turner earned a legion of fans for her riveting live performances, and was best known for songs such as "Private Dancer", "The Best", "What's Love Got to Do With It" and "Proud Mary".

Born Anna Mae Bullock on 26 November, 1939, in Nutbush, Tennessee, Turner would go on to sell more than 180 million albums and win 12 Grammy Awards.

Turner was diagnosed with intestinal cancer in 2016 and received a kidney transplant in 2017.

Stars of the entertainment world including Mick Jagger, Bryan Adams, Rosario Dawson, Paloma Faith and Naomi Campbell paid tribute to the iconic singer.

According to audience accounts in the Mail, the auditorium at London's Aldwych Theatre was filled with "gasps" when the stars came out and broke the news to the crowd during a performance on Wednesday night.

Caleb Roberts, who plays Ike Turner, made the announcement, with Kristina Love, who plays Tina, delivering a small speech at the end of the show.

The statement from the cast was "poignant" and "sombre", theatre goers said, with the show reflecting the idea that Turner herself "would have wanted the show to go on".

Former US president, Barack Obama: "Tina Turner was raw. She was powerful. She was unstoppable. And she was unapologetically herself - speaking and singing her truth through joy and pain, triumph and tragedy. Today we join fans around the world in honoring the Queen of Rock and Roll, and a star whose light will never fade."


Opportunities To improve The Host Community Development Trusts (HCDTs) Under Nigeria's Petroleum Industry Act (PIA)

Introduction he Petroleum Industry Act (PIA) was passed in August 2021, initiating the restructuring of regulation for the oil and gas sector in Nigeria, with a significant impact on communities that host operations. One section of the Act is focused on community development and provides for the establishment of Host Community Development Trusts (HCDTs) to increase social spending by oil and gas companies (OGCs) in host communities. While SDN's view is that this section of the act should have focused on a more holistic, government-led strategy for development in host communities and protecting them from the harmful impacts of hydrocarbon exploration and production, it does at least offer the hope for vastly increased social spending by OGCs, and greater autonomy of that spending for host communities.

The head of the Nigerian National Petroleum Company (NNPC) has stated that under the new legislation, huge sums of money - over US\$500 million per year - are due communities. This is a significant opportunity for investments into widespread community development. However, it is also the latest in a long line of initiatives which are meant to direct funding to communities impacted by the oil and gas industry (for example, the creation of the Niger Delta Development Commission (NDDC) and the 13% derivation provided to states). These have seen large amounts of revenue from the oil and gas industry flow to the region, but with limited results, for example, due to misuse of funds and benefit capture by certain groups. It is therefore of paramount importance that these pitfalls are avoided, and it is in the interest of all parties that the funds are calculated, collected, and utilised in a transparent and accountable way, and that they are directed to initiatives which are in the widespread public interest.

To manage the investments locally, Host Community Development Trusts (HCDTs) are being established. To guide implementation, accompanying regulations were issued by gazette in June 2022. Our close reading highlights that the PIA and HCDT regulations lay the foundation for managing these funds, but there are many opportunities to build on this to ensure best practice is followed in finance and governance mechanisms.

This report outlines some of the key concerns under these two areas – finance and governance – and provides specific recommendations for the legislature and regulator to consider, in their efforts to improve implementation of the HCDTs, and wider PIA. We have structured our discussion around some key questions we believe need to be answered, providing answers where we can, and

highlighted when more information and work is needed where we cannot. It is based on a close reading of the PIA, HCDT regulations, and from analysing the audited accounts of an OGC.

This is a major, complex new policy initiative, with many potential risks and benefits for communities. From our discussions with OGCs, the FGN, communities and wider civil society, it is clear that work is being done to try to navigate this complexity. However, the speed at which this is happening, and the focus on the business side of the reforms, may gloss over several critical issues related to host communities, which this report seeks to highlight.

Research and analysis findings Finances

When it comes to the Niger Delta and host communities, the first challenge is not lack of funds1, but the failure to use funds which have flowed to the region to the benefit of all citizens. For example, in 2020 alone, Federal and State Ministries, Departments and Agencies were allocated NGN1.4 trillion (US\$3.7 billion) (see Annex 1). Our later section on governance focuses on some of these issues. However, firstly there is a need to understand the scale of funds involved with HCDTs, and to understand the risks if information on this is not transparent, in a context where mistrust between communities, companies and government is prevalent, and where the

allocation of significant amount of funds is overlaid with locations where there are existing risks of intra- and inter-communal conflict.

How much funding are we expecting?

The PIA states that OGCs shall pay an annual contribution, "in an amount equal to 3% of its actual annual operating expenditure of the preceding financial year in the upstream petroleum operations affecting the host communities for which the fund was established".2 The Federal Government of Nigeria (FGN) claims the total will be huge, with the Nigerian National Petroleum Company (NNPC) Group Managing Director, Mele Kyari, quoted as saying:

"The operating expense in the industry is up to \$16 billion in a year. That means that 3% of that operating expenses is clearly somewhere around \$500 to \$600 million, it can even be as high as \$800 million. So, when you look at this, that value is almost bigger than the size of the budget of the N D D C (N i g e r D e l t a Development Commission). So, it is a really huge investment."3

The NDDC budget was on average US\$806 million (NGN206 billion) per year between 2012-2020 (see Annex 2). However, the total amount contributed to HCDTs is expected to be far lower than the NDDC levy, which is equal to 3% of the operating budget of the preceding financial year, and supplemented with a contribution from the

FGN.4 This is because the operating budget includes operating expenses (OPEX), as well as capital expenditure (CAPEX), plus other costs. On this point, the FGN ought to exercise caution in its communications, to avoid false expectations. The best way would be to publish total OPEX figures.

The definition of OPEX is itself open to interpretation. The HCDT regulations provide a fairly detailed definition of operating expenditure, which should take into account, "noncapital production costs, cost of sales, administrative expenses and any other expense incurred for the operations of the business on a day-to-day basis as included in the audited financial report, provided that such expenditures shall not include capital expenditures, impairment, depreciation or amortisation."5 However, it is understood that the industry definition of OPEX is different to the FGN definition as the latter typically does not include maintenance.6 This definition therefore leaves a lot of room for interpretation, and without a specific definition, companies may calculate their contributions differently. Therefore, we recommend that the regulator provides a specific definition, with the line costs to be included in financial accounting.

One thing is clear, the HCDT allocations will far surpass the existing non-mandatory social spending (CSR) of OGCs. The total of non- mandatory social

spending reported for all OGCs between 2012-2020 was US\$655 million, which is an average total of US\$72 million per year.7 The expected contributions to HCDTs are therefore expected to be many times higher than what is currently spent (see Annex 3).

How will communities be able to tell if they are receiving the funds they are due?

At present, there appears to be a large transparency and accountability gap, what funds should be due to their HCDT and whether they have been received. Communities will not be able to validate what they are owed, because almost all companies do not publish their detailed annual audited accounts or budgets. These details are reported to the upstream industry regulator (Nigerian Upstream Petroleum Regulatory Commission, NUPRC), the manager of FGN interests in the industry (National Petroleum Investment Management Services, NAPIMS), and the Federal Inland Revenue Service (FIRS). But without publishing this information, the amount the companies should be remitting to the HCDT cannot be independently verified.

Moreover, compliance with provisions to fund NDDC has reportedly been poor. The FGN claims that several OGCs fail to submit their allocations, and that the deficit was US\$4billion in 2021.8 This is exacerbated by the fact that NDDC has no statutory powers to compel the release of funds, or impose penalties for non-compliance. The NUPRC does have powers it can exercise if payments are not forthcoming including issuing penalties up to US\$250,000, and making recommendations to the Minister of Petroleum Resources to revoke a lease.9 This is positive, although it remains to be seen whether the NUPRC will follow through to compel the timely release of funds due.

How will the funds be calculated and split among Trusts?

Dividing the contributions mong HCDTs will be complicated for a number of reasons. Firstly, there is no guidance in the regulations on how to form a HCDT cluster. It is therefore left to the OGCs to decide which communities are hosts to their facilities, group them into HCDTs, and calculate how much they are due.10 The regulator will have to approve the grouping of communities under HCDTs, but this may be done without ample risk assessments. This has the potential to cause conflict in areas where there are existing community-level disputes, for example, over territorial borders, and existing revenues and opportunities from the oil and gas industry. While HCDT structures have a range of positions that should ensure broad-based community representation, there could still be disputes when selecting

representatives and projects.

Moreover, the OGC contributions will need to be split among different HCDTs, and there is no guidance in the regulations on how this will happen. The ad hoc approach to grouping communities will make it more difficult to calculate how much each HCDT is due, and for communities to verify this. If, for the sake of argument, HCDTs were based on existing oil mining licence (OML) boundaries, then production is already calculated and published at that level. However, in an ad hoc approach, the OGCs must calculate their production within the territory of each HCDT, assess how 'impacted' each area is, and then apportion contributions.11 The regulations specify that the settlor should design a funding matrix for the proposed allocation of funds to host communities "based equitable and on economic principles".12 But it also outlines that "the commission may issue a template of fund distribution matrix to serve as a guide to settlors." We recommend that the NUPRC exercises this right, and issues a uniform template, if it has not done so already, so all companies follow the same principles. Otherwise, there will inevitably be disputes with communities.

To further complicate this, all operations in Nigeria are under a Joint Venture (JV) or Production Sharing Contract (PSC). In arrangement, various companies have a different equity share, contribute different levels of investment, and take different profits. Therefore, it is not clear how HCDTs will manage this issue, since it could become confusing to calculate the contributions due on a companyby-company basis, when the allocation of HCDTs to companies is different to the JVs. In addition, offshore oil blocks are set to make contributions to 'littoral communities' "located along the Gulf of Guinea of the Nigeria shoreline up to about 500 metres inland", who will be "assigned to a settlor by the Commission (NUPRC)".13 In terms of contributions from offshore operations, they will

be "pooled and distributed amongst beneficiary trusts equitably considering annual operating expenditure of the preceding financial year, asset value size, and any other criteria as may be determined by the Commission."14 This is another grey area where the regulator should intervene, to create a uniform approach to allocating funds from offshore production, to communities along the coastal

Case study: Calculating contributions

From an outside perspective, calculating the contributions due to HCDTs is currently not possible. We attempted to do this and ran into several challenges, which others will face when attempting to verify what HCDTs are due, and whether OGCs are

them. More will need to be done to by the FGN and OGCs to align HCDTs with commitments to transparency and accountability. We sought to analyse the audited accounts of several OGCs, but could only find published reports for one domestic oil and gas company. In this process, we observed the following:

. The majority of OGCs do not publish their annual audited accounts so there is no transparency on OPEX.

International oil companies publish their annual audited accounts, but these cover the entire company, and they do not show the figures for their subsidiaries in Nigeria.

- Most companies are involved in upstream (production) and downstream (distribution) activities, and the OPEX for each is not separated in reports. Some companies are only involved in upstream activities, but they also have operations that are not directly impacting host communities, such as international offices, and sole cost projects, such as shares in power plants. Their reported OPEX totals cover all these activities, and it is not possible to separate for onshore oil and gas operations.
- All companies operate in Nigeria under joint ventures (JVs), where they have a share in the producing asset (e.g. NNPC 55%, SPDC 30%, Total 10%, Agip 5%), and OPEX is not reported on a JV basis. It is therefore not clear how contributions to HCDTs will be calculated under JVs.
- · When we used the definition of OPEX provided in the HCDT regulations, we found that 3% of a company's total OPEX was far higher than the amount they reportedly remit to NDDC. This should not be the case, as the NDDC levy is based on 3% of the operating budget, which includes OPEX, CAPEX, and other costs. Therefore, this implies that the OGC either uses a different definition to calculate their OPEX, have not fulfilled their mandatory NDDC payments, or NNPC contributed their share.
- · In the industry, the definition of depreciation, depletion and amortisation (DDA) is subjective, meaning companies will calculate the costs to be deducted from their OPEX in different ways. Furthermore, DDA applies to CAPEX more than it does to OPEX, so it is not clear how much should be deducted from the contribution.

How much can be deducted for damage to infrastructure and what are the implications for host communities?

Petroleum Industry Act (PIA) states that deductions can be made to HCDT funds to cover "the cost of repairs of the damage" that result from "thirdparty damage", when "an act of vandalism, sabotage, or other civil unrest occurs that causes damage to petroleum and

making the payments required of designated facilities or disrupts production activities".15 However, the Host Community Development regulations appear to significantly broaden what is stated in the PIA, to allow deductions for not only for the cost of repairs and replacements,

- the value of products lost as a result of the action (crude oil, gas, or products);
- the operating expenditure incurred during the period that production was shut down.16

On the face of it, it appears the regulations are a significant overreach on what the legislation permits. If implemented, this could lead to huge deductions to HCDTs, but it is challenging to establish exactly how much. During 2022, FGN sources publicly estimated as much as 200,000 to

(CSOs), who claim that the regulator and OGCs often underreport the total volume spills, and regularly misattribute the cause as thirdparty, instead of operational failure, to avoid paying fines and compensation. Under the PIA, if OGCs can charge communities the associated costs, this is a potential incentive to report more spills as third- party damage, and to increase their estimates of total spill volumes.

Furthermore, single extreme incidents could exhaust funds allocated to HCDTs. As an illustrative example, it has been claimed that third-party damage was the cause of a spill at OML 29 in Nembe in November 2021. No official joint investigation visit report has been made public, but independent estimated that at least

500,000 barrels of oil were

and civil society organisations a failure of oil companies to protect their infrastructure, of security agencies to perform their role effectively, and of the FGN to provide an effective and holistic policy response to tackle the underlying causes of the problem.

> Finally, the reality of the artisanal oil industry is that it is controlled by organised, often heavily armed groups - and as is now publicly acknowledged, even in the National Assembly, with the collusion and active participation of a range of groups and influential individuals.

> This has enabled the informal sector to grow in scale over the past two decades, with the FGN and OGCs unable to stop it, despite spending billions of dollars on military operations and hardware. This is a major problem across the Niger Delta and simply passing the costs that oil companies incur onto community



400,000 barrels of oil a day were being stolen, so the deduction could be US\$365-730 million per year (at US\$50 per barrel, a price well below the current oil price).

The total deductions rise sharply when other permitted deductions are included, such as pipeline repairs, which according to NNPC statistics, costs on average US\$370 million (NGN110 billion) per year.17 Assuming 80% of damage is due to third-party sabotage as OGCs claim (and this equated to 80% of the cost of damage), this equals US\$296 million

(NGN88 billion).

Based on the cost of oil lost and pipeline repairs alone, under the new definition in the regulations, HCDTs could theoretically have US\$661 million to US\$1 billion (NGN303

458 billion) deducted every year. This exceeds the amount they are estimated to receive. The total could be even higher, as this does not include the value of other products, and operating expenditure during down time.

Furthermore, this provision will be controversial under the current system of recording and reporting oil spills, which is highly contested by communities

lost.18 At \$50 per barrel, this would amount to US\$25 million alone (NGN10 billion), on top of the other permitted deductions. Taking a more modest estimate of 50,000 barrels, this would still cost US\$2.5 million (NGN1 billion) - which is still likely to be more than the total contributions to the local HCDT.

This highlights a broader question SDN has previously asked surrounding third-party damage - why should whole communities be held accountable? The situation is undoubtedly complex: the lack of jobs and access to energy in communities in the Niger Delta are among the drivers for the artisanal oil industry. These drivers have in part been created by the oil and gas industry, for example, through historic oil spill pollution which has destroyed local livelihoods. In turn, this situation has created a level of reluctant acceptance in communities for the existence of the artisanal oil industry, and the further environmental damage this creates on top of the damage already caused by OGCs

On the other hand, for this illicit industry to exist in the way and scale that it does, there is a failure of all actors. For example,

members without adequate support is not an effective solution.

SDN campaigned for this provision to be removed entirely. as it abdicates OGCs from their responsibility to protect their own infrastructure, places an unfair onus on communities to ensure the security of oil and gas infrastructure, and punishes entire communities for the actions of a few, which may be completely outside of their control.19 At the very least, based on the fact that this provision in the regulations appears to be out of line with the PIA, we expect this can be challenged and hopefully the regulations can be reviewed to bring them back in line with the PIA.

Governance

With larger amounts of money allocated to communities, it is important that the correct governance structure is in place to coordinate planning, spending, and ensure accountability. New structures are being established for this purpose, but there is a lack of guidance, several grey areas open to interpretation, and several issues arising from the

regulations.

Who will be involved in the Trusts and what will they do?

There were some welcome changes made in the final version of the PIA, for example clearly stating that community representation is required in certain parts of the structures, yet we fear they do not go far enough to ensure that communities have a significant and meaningful say on how HCDTs operate. On paper, the settlor (i.e. the OGC) retains a disproportionate level of control over management and direction of the HCDT-although in our discussions with OGCs, a number suggest that once the HCDT is set up, they will have very limited control and involvement beyond providing the funds. Regardless, the topdown structure provides layers of administration and upwards reporting and accountability (e.g. to the OGC and government), but very little provision is made for ensuring accountability to communities and ensuring regular communication, reporting, consultation and participation.

The structure of the HCDTs is outlined below, with their roles unpacked, as specified in the PIA and regulations. This is what the regulations require to be established in every group of communities that 'host' the operations of OGCs. The vast bureaucracy could become highly burdensome, and without guidance, risk causing disputes over control of the different structures. This could be improved, for example, by creating guidelines, and rolling these out across the industry. It could be produced in a multistakeholder process between OGCs, communities, and the

Another positive change in the final version of the PIA was to ensure the Board of Trustees (BOT) for every HCDT is composed of members of the host community, and that there must be consultation with communities on their selection20. However, the settlor funded? retains the right to determine the criteria for appointments, without any requirements to consider gender or age, and it has powers to remove members21. This could lead to a situation where a handful of representatives - i.e. those who are already influential in the oil and gas sector, typically middleaged and elderly men - will decide what projects are implemented, who is awarded contracts, and could scheme to create a cartel to capture these Furthermore, the maximum number of BoT members is nine – so HCDTs that cover more than nine communities will force them to compete for representation.

Committee is responsible for the general administration of the HCDTs, so it is positive that executive members must have experience in relevant professions, and that appointments must "give due consideration to diversity as it relates to age, gender, and physical disability".22 However, it is not clear how the roles of these executive members - who will not necessarily be members of host communities - differs from the roles of the community representatives, who will serve as non-executive members. In corporate governance, nonexecutive directors typically provide oversight and insights to challenge executive directors. But that is at the director or board level, and the management committee is at the level below this, so they will not have usual powers to challenge executive members and remove them if performance is sub-standard. The structure therefore risks concentrating power with executive members, who are not from host communities, and appointed by the BoT, while non-executive members from the host communities could be accommodated for the sake of representation, without any formal role in day- to-day management.

The Advisory Committee has been given the responsibility for monitoring project implementation, and reporting to the Management Committee. Yet there is no guidance on what or how to monitor the impact and outcomes. This will likely be a significant undertaking, and it is not clear what proportion of the 5% of HCDT funds allocated to administrative purposes will be allocated to the advisory committee. There is a significant opportunity to develop an enhanced approach, which involves regular community consultation, monitoring and evaluation, and iterative updates of development plans, in line with best practice from the development sector.

Who decides what gets

A needs assessment will be carried out in each HCDT at the outset. One positive change in the regulations is that the settlor has to show evidence it has engaged with each affected community to understand the issues and needs; consulted with and considered the concerns of women, youth and community leaders, and; engaged with each affected host community in developing a strategy to address the needs and effects identified in the applicable needs assessment.23 However, this will only happen at the outset, and be reviewed every five years, which could be improved by creating regular opportunities for community feedback, to make updates based The Management on changes in issues and

context.24 NUPRC reportedly has a template for needs assessments, but this does not appear to be enforced. In observed HCDTs, the approach used was not comprehensive e.g. one settlor sent 50 forms for community members to fill their needs.

Moreover, the requirements for consultation do not extend to Anecdotally, in our informal discussions with OGCs, they have expressed concerns about the short timeframes given for needs assessments, and the complexities they will face in developing robust community development plans.

Because development of the plan rests with the settlor, it is ultimately within their power to communities, as we have seen with other initiatives in the Niger Delta.

While there of course needs to be a decision- making structure which prioritises initiatives from community consultations, we are concerned that the current process is not open enough and too much power rests with the settlor, which could be prone to capture by individuals or interest

the subsequent community development plan, which is the key document guiding the strategy and project selection under the HCDT.25 The settlor is only required to consult with the proposed BoT members, and submit the development plan to the NUPRC for approval, after

30 days of completing the needs assessment.

This does not provide adequate time for thorough consultations to occur with the affected communities, even if this was required of the settlor, which it is not. As a result, OGCs may use existing needs assessments that were conducted for previous CSR projects, which will be outdated and geared towards OGC priorities.

define the issues to be addressed: set the objectives and strategy of the fund; determine and specify the community development projects to implement; and set the budget and timeframe for implementation.26 Therefore, community members may be consulted on their needs at the outset, but there is no guarantee that they will have a say in the design of the overall strategy of the development plan, or the projects that are implemented, nor will they be part of validating or approving the final plan, as this is left to the regulator. The process could even be open to elite capture of the benefits, potentially creating further fault lines along which conflict can emerge within and between

groups. Even if a settlor were to behave in completely responsible way, they will be open to accusations of bias, thus creating further risks of conflict. Without mechanisms to ensure consultation and feedback from community members, the only way they can have a say in the project selection will be by lobbying members of the Board of Trustees, Management Committee, and Advisory Committee. If these channels are not productive, disgruntled community members may turn to sabotaging protest or infrastructure, as has become common during lingering disputes with OGCs across the region.
